working of The Indian Society for Sponsorship and Adoption for the period
April 2017 to March 2018**

This year has been an emotional year for the society. From the 12th of March 2018, we have shifted our Adoption Office to the premises of Nava Jeevan Home. Our Sponsorship office and registered office remains at Kyd Street. To shift the Adoption office from Kyd Street we had to create more space for the children staying at Nava Jeevan Home. Thus the terrace was covered and a dormitory, two childrens' rooms and an activity room was created on the top floor. The ground floor hall was divided into two with the office in one half and the storage in the other half. The requirement to shift the office to the Home was done as the files of the children were expected to be on the same premises as the children.

On the 1st of April 2017 we had a total of 61 children in our SAA Home, Nava Jeevan, of which 31 were male and 30 were female. Likewise, on the 1st of April 2017 we had a total of 43 female children in our Nava-Diganta Home.

In the period April 2017 to March 2018 we received 37 children in Nava Jeevan Home of which 24 were girls and 13 were boys. During the same period we received 313 girls in Nava Diganta Home, all of them were girls. Of this 236 girls were restored to their families. There were 74 children who were transferred to other institutions.

On the 31st of March 2018, we had 47 children in our SAA Home, Nava Jeevan of which 26 were female and 21 were male. In our CCI Home, Nava Diganta Home we brought forward 46 female children.

ADOPTION PROGRAMME

The Central Adoption Resource Authority has notified new Regulations on the 4th of January 2017 which came into effect from the 16th of January 2017. The existing system continues with some modifications to the process. The scope and authority of CARA has been extended to include children of relatives and the adoption of step children. The age criteria for such cases have been relaxed. Couples with three children or more are not eligible for adoption with exceptions made for hard to place children. Prospective Adoptive Parents can indicate their preference of the State that they wish to adopt from, they can choose the gender as well as the age of the child which will determine their choice. The validity of the HSR has been extended from 2 years to 3 years.

District Child Protection Unit is expected to publish the photograph of the child in 3 working days in an effort to trace the biological parents of the child. The number of children offered to prospective adoptive parents has been reduced to three from the previous six, and only one referral is sent to the Prospective parents at one time. In case of rejection, another referral is sent after 60 days.

Prospective Adoptive Parents continue to choose us as a HSR Agency. We continue to use the SARA (State Adoption Resource Agency) appointed Social Workers. Home Study requests from other districts are being referred to State Adoption Resource Agency for transfer to a SAA of that district.

We continue to have a very large number of children at Nava Jeevan Home. Our caregivers, and other staff members are working tirelessly to look after the children under our care. We have under our care an average of 55 children at any given time. We thank the dedicated efforts of our Home staff who have worked round the clock with the children. Our Visiting doctors come once in 24 hours and look after the medical needs of the children. We also have a team coming in from the Rashtriya Bal Swasthya Karyakram (RBSK) to both our Homes. In spite of our best efforts, we have lost one child in the year. Sikha, passed away at the Dr. B.C. Roy Post Graduate Institute of Paediatric Sciences.

NAVA DIGANTA HOME

Our Child Care Institute for older girls, Nava Diganta, is now a Home for girls in the age group of 6 to 18 years. New systems as per the provisions of the

Integrated Child Protection Scheme (ICPS) are strictly adhered to. The age group of the children at Nava Diganta Home is 6-18 years. The Team at Nava Diganta Home is working hard to maintain discipline among the children. This proves to be quite a challenge. We keep them busy by designing various activities throughout the day. The children who are of school going age and are with us for long term care are sent to the local school.

Our Vocational Training Unit is making different items, like paper bags, cards, and small items of costume jewellery. The Tailoring Unit is also helping the residents to learn items of use.

ANNIVERSARY CELEBRATIONS

The 42nd Anniversary of the Society was celebrated on the terrace of Nava Diganta Home on the 17th of December 2017. The children living in Nava Diganta Home, some of the children in Nava Jeevan Home took part in the small cultural programme that was organized. The children attending the event with their parents also presented songs and dances. The children enjoyed themselves thoroughly. A simple lunch was organized for all our guests.

A. CRECHES RUN BY ISSA

ISSA is running crèches in Mominpur and Thakurpukur in Kolkata, Nilgunj in North 24 Parganas and Bara Andulia in Nadia district. We also support coaching class in the vocational training in Chetla. Projects are coordinated with Project Coordinators and they continue to do a good job. National Days are celebrated in the crèches and coaching classes.
